The request for granting legal personality was submitted by the applicant, the **ROMANIAN ASSOCIATION OF SKI JOURNALISTS**.

Following the roll call for the session, it was found that the applicant's representative was absent.

The case was presented by the court clerk, who showed that the party failed to follow the summoning procedure.

The Court proceeded ex officio to verify its jurisdiction, according to art. 529, para. (1) of the Civil Procedure Code, establishing that it has general, material and territorial competence to resolve the request, based on art. 5 para. (1) of the Government Ordinance No. 26/2000.

The Court admitted the documentary evidence, then considered the case for settlement.

T H E C O U R T,

Considering present application, finds the following:

By filing the application to the Timișoara Court of First Instance on 04.05.2017 under no. 10847/325/2017, the applicant, the **ROMANIAN ASSOCIATION OF SKI JOURNALISTS**, through Bartha Csaba, president and Boga Dan-Flavius, lawyer requested the court to be entered into the Register of Associations and Foundations in order to obtain legal personality.

The applicant requested the case to be heard even in the absence of its representative.

As legal grounds, the provisions of the Government Ordinance No. 26/2000 were invoked.

The following documents were submitted to support the application: proof of availability of the association name, issued by the Ministry of Justice under no. 160606/ 11.04.2017, in the original form, the agreement of the General Secretariat of the Romanian Government on the use of the name, the "Romanian Association of Ski Journalists", in a copy, minutes for the establishing of the association, the memorandum of association authenticated under no. 313/ 11.04.2017 and

the articles of association authenticated under no. 314/ 11.04.2017, both by the lawyer, Bogea Dan-Flavius, registered with the Timiș Bar Association, land registry extract no. 410596-C1-U2 Timișoara, bailment agreement as of 11.04.2017, all in the original form, a power of attorney in reference to association management, in a copy, cash deposit receipt amounting to 1,500 RON that make up the initial patrimony of the association, fiscal record certificates for the associates, all in the original form, ID cards of the associates, in a copy.

The applicant provided proof of payment of the stamp duty in the amount of 100 RON.

Analyzing this application, the Court acknowledges the following:

Individuals and legal entities pursuing certain activities of general interest or in the interest of communities or, as appropriate, in their private non-patrimonial interest may establish associations or foundations under the conditions of the Government Ordinance no. 26/2000 on associations and foundations, amended and completed.

The Court finds that the applicant has submitted the documents provided by art. 7 paragraph (2) of the Government Ordinance no. 26/2000 and that they comply with the legal provisions in the matter for the establishment, organization and functioning of associations.

According to the memorandum of the association authenticated under no. 313/ 11.04.2017 and the articles of the association authenticated under no. 314/ 11.04.2017, both by the lawyer, Bogea Dan-Flavius, the association was founded for an indefinite period of time, it is called the ROMANIAN ASSOCIATION OF SKI JOURNALISTS, its head office is in the Municipality of Timișoara, Brediceanu Street no. 9, ap. 1, Garage, Timiș County and its board of directors is made up of the president of the association – BARTHA CSABA, the vice-president – IONESCU RADU-CRISTIAN and the secretary general – DANCI CĂLIN-MARIUS.

In addition to the matters set out above, the Court will accept the applicant's request and will order the registration of the applicant in the Register of Associations at the Timișoara Court Registry.

**FOR THE FOREGOING REASONS,
IN THE NAME OF THE LAW,
THE COURT DECIDES:**

The Court accepts the application for obtaining legal personality submitted by the applicant, the ROMANIAN ASSOCIATION OF SKI JOURNALISTS, with mailing address chosen to be the office of Bogea Dan-Flavius, lawyer in the Municipality of Timișoara, Lucian Blaga Str. No.1, 1st floor, ap. 1, Timiș County.

The Court orders the registration of the applicant in the Register of Associations at the Timișoara Court Registry as a non-profit private legal person, according to the memorandum of the association authenticated under no. 313/ 11.04.2017 and the articles of the association authenticated under no. 314/ 11.04.2017, both by the lawyer, Bogea Dan-Flavius, member of the Timiș Bar Association, founded for an indefinite period of time, under the name of ROMANIAN ASSOCIATION OF SKI JOURNALISTS and with the head office in the Municipality of Timișoara, Brediceanu Street no. 9, ap. 1, Garage, Timiș County, the board of directors being made

up of the president of the association – BARTHA CSABA, the vice-president – IONESCU RADU-CRISTIAN and the secretary general – DANCI CĂLIN-MARIUS.

With the right to appeal within 5 days from the communication, a notice of appeal shall be filed at the Timișoara Court of First Instance.

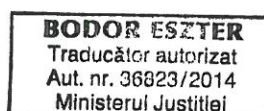
